With reference to above cited subject, I am directed to communicate that as per Academic Council Resolution No. 59/2021 dated 28/07/2021 and as per your proposal of Continuation of Affiliation/Extension of Affiliation, the Academic Council unanimously resolved to grant Continuation of Affiliation / Extension of Affiliation for Academic Year 2021-2022 as per the provision u/s 68 and 65 (4) of MUHS Act 1998, for the Homoeopathy (Under Graduate) **B.H.M.S.** course of your college.

(a) The intake capacity shall be 50

(b) Grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/ National Commission for Homoeopathy/State Government (as applicable).

(c) Fulfillment of following **deficiencies** shall be strictly complied within Ninety Days without fail.

Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2021-2022 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy.

1. While examining the facilities, it is found that there are deficiencies of 03 hospital equipments. Stretcher with trolley 01, Oxygen cylinder with stand 01 Diagnostic set (ENT) 01 not available as required.
2. The college has 23 eligible full time teachers (24 required).

3. The college has 07 eligible Guest faculties available (required 08). Documents and experience of Dr. Bindusar Palange has been provided but Affidavit for same has not been provided.
4. List of 08 part time teachers provided with documents (required 09).
5. Biometric Attendance of only October 2021 is provided by the college.
6. Form-16 not provided by the college (undertaking in compliance that it will be provided within 3 months). Acquittance provided till March 2021.

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, **Conditional permission of the Medical Assessment and Rating Board is issued to Shri Tatyasaheb Ghatake Charitable Trust, R.R. Patil College of Homoeopathy & Hospital, Sangli Pune Bypass Sangli, Maharashtra- 416416 to Ist BHMS course with intake capacity of 50 seats in Undergraduate (BHMS) course for the academic year 2021-22.** The Principal is directed to fulfill the deficiencies within 30 days and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

4. All admissions in Under Graduate/Post graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 for conducting the course. All deficiencies observed, has to be rectified within 30 days' time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
